Mr. Warne also visited GLRA India's leprosy project sites together with Dr. Srilekha Penna, ILEP India Coordinator and Regional Research Coordinator, GLRA India to gather insights into their work in Leprosy in high-priority states and districts.



- Visits were made to Sivananda Rehabilitation Home (SRH), Hyderabad, Vimala Dermatological Centre, Mumbai, and Dayanand Hospital, Palghar along with outreach skin clinics in tribal villages of Talasari which are supported by GLRA India.
- Various insights were exchanged by the medical and paramedical teams on their innovative efforts to manage leprosy in the hospitals. The team further interacted with persons affected by leprosy in the local communities who shared their success stories of overcoming stigma and discrimination and are now leading a life with confidence.

2 Participation in the Regional COR-NTD Meeting for South-East Asia

A two-day Regional COR-NTD (Coalition for Operational Research on Neglected Tropical Diseases) meeting for South-East Asia was organized at New Delhi on 18th-19th April by WHO SEARO (South-East Asia Regional Office).

Different officials and representatives from NCVBCP (National Centre for Vector Borne Control Program) – Govt. of India, WHO SEARO, NTD department – WHO HQ, Piramal Foundation, ILEP Federation, ILEP India members, several educational institutes of Public Health & Tropical Medicine and many other stakeholders joined the meeting.


4 Exchanging Knowledge and Learning – ILEP India Knowledge Sharing Series

A session on "Odisha's progress towards declaring leprosy as a reportable disease" was taken up by Dr. Rituparna Hota, NLEP Consultant - Odisha, LEPRA Society on 16th April which provided the states and other stakeholders a momentum to step up for reporting every leprosy case.

Another insightful session on "Burden and management of post-RFT issues in Leprosy" was presented by Dr. V.V. Pai, Director, Bombay Leprosy Project on 10th May which highlighted aspects related to clinical, social, and physical issues post RFT, strategies, and recommendations from WHO, ILEP and NLEP, Post RFT surveillance and Risk identification, ensuring and taking responsibilities of patients after treatment, etc.

6 GLRA India's Commitment to Zero Leprosy through its flagship project NIRAMAYA III

- GLRA India remains steadfast in its commitment to progress towards Zero Leprosy and strengthens its leadership, commitment, and partnerships with the National Leprosy Eradication Program (NLEP) in India.
- Through its flagship project NIRAMAYA III, GLRA India is working in 7 high-priority states (Andhra Pradesh, Chhattisgarh, Madhya Pradesh, Maharashtra, Telangana, Tamil Nadu, and West Bengal) supporting tertiary care facilities, outreach activities, urban leprosy programs, and ILEP-NLEP state coordination.
- On 28th June 2024, a meeting was held at Swasthya Bhavan, Kolkata, under the leadership of State Leprosy Officer Dr. Pralay Acharya together with Mr. Shibu George (Interim CEO, GLRA India), Dr. Srilekha Penna (ILEP India Coordinator and Regional Research Coordinator, GLRA India), Dr. Abhijeet Nandi (ILEP-NLEP Consultant, GLRA India), Dr. Arup Chakrabarthy (ILEP-NLEP Consultant, NLR India), and the paramedical team of GLRA India to discuss the GLRA India's strategic plan for the state from 2024-2026 under NIRAMAYA III.

 GLRA India affirmed its ongoing commitment to supporting West Bengal and discussed enhancing ILEP-NLEP state coordination across 22 districts and strengthening the Urban Leprosy Program in Kolkata through 6 medical colleges ensuring a comprehensive approach to leprosy management.

Supporting the clinical services for persons affected (DFIT's quarterly update)

Damien Foundation India Trust (DFIT) during the quarter has implemented a leprosy control programme in seven states across the country, through its own three hospitals, seven partnership project hospitals, 13 Disability Prevention and Medical Rehabilitation field teams, and its rehabilitation home for the persons affected by leprosy.

Through OPD services, 18473 patients were treated and 174 new leprosy cases were detected out of these patients; 38 persons were detected with grade 2 disability and 67 patients were female patients.

Treatment to 292 patients with 7544 bed days was provided; 83 patients were treated for lepra reaction. Deformity corrective surgeries were conducted for 61 patients while MCR footwear was provided to 278 persons.

 DFIT reached out to 2678 patients through its field activities and counselled them for the self-care practice among them 1913 are practicing self-care. Besides the regular activities, field teams have provided leprosy training to ASHAS, M.O, and Physiotherapists.

Dr. Suchitra Lisam, Head - Research & Knowledge Management, NLR India, and Mr. Sayantan Halder, Research Coordinator, PEP App, NLR India participated and presented research progress updates of NLR India's research studies.
- Dr. Suchitra Lisam presented the study titled "Compassion Training for Reducing Stigma and Improve the Quality of Care of Persons Affected by Leprosy".

- The team also took part in the Expert Group Meeting on "Development of Telacebec drug-related research proposals, funding opportunities: EDCTP3 deadline" which was chaired by Dr. Liesbeth Mieras, Coordinator, Research & Advocacy, NLR India.
- Mr. Sayantan presented the study titled "Testing an App supported delivery system LPEP". The LRI's Spring Meeting brought together over 100 attendees from over 30 countries including LRIfunded researchers, LRI committee members, partners of LRI, and other attendees with a particular interest in leprosy research.

9 Swiss Emmaus India held a national consultation on leprosy and migration

Swiss Emmaus Leprosy Relief Work India (SEI) held a national-level consultation on leprosy and migration in India, with key ecosystem partners with the objective of finalizing the definition of a 'migrant' in the context of leprosy, and its integration in the National Leprosy Eradication Program (NLEP). The findings from The primary data collection to draw key recommendations for the NLEP program was presented.

The day-long event saw active participation; the data presentations evoked invigorating engagement among the delegates; both online and offline.

The national level consultation was followed by a meeting of the Technical Task Force (TTF) committee on the finalization of the agenda, i.e., finalizing the term 'migrant'. The online gathering was also presented with draft IEC materials proposed in the project for community awareness of leprosy. The TTF members made active contributions with their feedback and viewpoints on how to better the communication efforts. The finalized IEC contents are translated into a graphical Hindi poster as additional IEC material for the NLEP program.

From April to June 2024

ILEP agencies continued to support field and policy-level assistance to the National Leprosy Eradication Program (NLEP) through their 14 NLEP consultants across 11 highpriority states and few other states. These consultants routinely visit the health care facilities, organize self-care camps, assist district and state leprosy officers, train the selfhelp groups, monitor the drug availability in the districts, and assist in active case detection activities.

Celebrating World Environment Day to Generate Awareness

NLR India Team organized a week-long Plantation Drive that was carried out from the 5th to the 13th of June 2024 in observance of World Environment Day (WED) which falls on the 5th of June 2024. Across several locations in six states namely Delhi, Rajasthan, Jharkhand, West Bengal, Uttar Pradesh, and Bihar, NLR India's staff planted 455 saplings in leprosy colonies, community parks, office premises, etc with the support of a total of 377 stakeholders from communities, peer supporters, beneficiaries, change agents and government agencies (Forestry Department, Health/Leprosy Cell, etc.).

During the drive, NLR India's staff also spread general awareness about WASH, heat stroke, etc. to the general communities, persons affected by leprosy, and their dependents. This is NLR India's first such initiative as NLR India has taken a pledge with USAID's Sustainable Action for Climate Health (SACH) towards a greener /healthier Planet.
